



IN THE DEPARTMENT OF TELECOMMUNICATIONS, MINISTRY OF  
COMMUNICATIONS AND INFORMATION TECHNOLOGY**

One post of Member (Technology) in the Department of Telecommunications carrying pay and allowances equivalent to that of Secretary to the Government of India, will fall vacant on 01.03.2012. Member (Technology) is also ex-Officio Secretary to the Government of India. The tenure of the post is till the incumbent attains the age of 60 years. In accordance with the Government Resolution constituting the Telecom Commission, the Members of the Commission are to be drawn from the best person available, including from within the Department of Telecommunications.
