

1. Files containing 2 copies of draft replies to **STARRED QUESTIONS** alongwith **notes for supplementaries** shall be submitted as immediately as possible and in any case latest by **11.00 am on Monday (21.02.2011)** to Secretary (T)/Secretary(P) for further submission to **Hon'ble MOC&IT before 12.00 p.m. on Monday (21.02.2011) positively.**
2. The Note for Supplementaries (alongwith executive summary in bullet form of not more than 2 pages) in respect of Starred Questions should be prepared and 20 copies (not signed) supplied to Parliament Section by **12.00 p.m. on Monday (21.02.2011) positively** for making pads for Hon'ble MOC&IT/MOSC&IT(K)/MOSC&IT(P)/PMO/Sr.Officers. The notes should be neatly typed. Out of these 20 copies, 06 copies should be in original computer print.
3. Use of abbreviations may be avoided and in case they are used, their full form may also be given in the brackets. It has been observed that illegible photocopies of annexures are being appended. **It is, therefore, requested that both original copy or neat, clean and legible copy of the annexures/enclosures may be attached.**
4. Files containing draft replies(2 Nos.) to **UNSTARRED QUESTIONS IN RESPECT OF DOP/DOT** should reach concerned Members **latest by 12.00 noon on Monday (21.02.2011)** for further submission to **Hon'ble MOSC&IT(K)/MOSC&IT(P)** in both English & Hindi versions before **2.00 PM on Monday(21.02.2011).**
5. Draft reply may please be signed by the concerned Sr.DDGs/DDGs and subsequent correction duly attested by the concerned Officer.
6. As all the question are required to be e-mailed by Parliament Section to Lok Sabha Secretariat in **MS Word, 2003 file**, it is requested that answers of the questions may be e-mailed to Parliament Section in **MS Word, 2003 file only**. It has been noticed that answers to the questions are being e-mailed, inter-alia, in *Excel file or window, 2007 file*, which unnecessarily delays the whole process. It is therefore, requested that the answers to the questions be e-mailed only in **MS Word, 2003 file** as soon as the file is cleared by Secretary/concerned Members.
7. The names of the officers who are to attend Official Gallery may please be intimated to Parliament Section latest by **Tuesday (22.02.2011) before 12.00 noon** after which it would be difficult to make passes for them.
