SUBJECT: APPOINTMENT TO THE POST OF MEMBER(SERVICES), TELECOM COMMISSION IN THE DEPARTMENT OF TELECOMMUNICATIONS, MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY.

One post of Member(Services) in the Telecom Commission in the Department of Telecommunications, carrying pay and allowances equivalent to that of Secretary to the Government of India will fall vacant on 01.02.2010.
