(B) Eligibility, terms & condition for candidate on contract basis

- Retired judicial officers who have superannuated after working in District Court and have the eligibility for deputation etc., and are not more than 64 years of age on closing date of receipt of application. Eligible officers who are going to superannuate on or before 30th April, 2018 and willing to join after their superannuation, may also apply.
- TDSAT shall pay monthly fee on contract basis. The fee may be determined on the basis of Last Pay drawn.
- 3. During period of engagement in TDSAT, no outside employment is permitted.
- 4. Entitled for 8 Casual leaves in a year with pro-rata entitlement for part of a year. Entitled to Gazetted leaves, weekly off. No other leave admissible. However, may be called for work on Holidays and weekly off without any extra remuneration.
