On behalf of Department of Telecommunication (HQ), sealed tenders are invited for the maintenance of the following items at the Offices located mainly at Sanchar Bhawan, Dak Bhawan, premises etc. and residences of officers spread throughout the Delhi for a period of one year.

Computer systems (390 No.) along with scanners (17 No.), CD Writers (6 No.) and Printers (339 No.) of different make along with maintenance of switched Ethernet LAN consisting of Switches (26 No.) Information Outlets (500 No.) and enhanced CAT-5 / CAT-6 Cable (32 KMS), OFF LINE UPS 1 KVA (409 No.) etc. at Sanchar Bhawan New Delhi.

Vendor Eligibility Condition: -

- (i) The company who already have the experience of maintaining a minimum of 300 PCs or more with peripherals for more than two years in any Central Government Departments / Ministries/ Govt. undertakings/ Private organization along with maintenance of switched Ethernet LAN system having more than 300 nodes are eligible to participate in the bid.
- (ii) The company should have at least Rs.5 Crores of annual turnover from its AMC of IT assets services business only, in last two financial years. Turn over certificate from Chartered Accountant to be enclosed.
- (iii) The company should have the facility / Application Service Provider partners of at least three of the company like HP, Compaq, IBM, Intel, EPSON, Microsoft, RED HAT, Wipro, HCL, Xerox, Acer, Samsung etc.
- (iv) The company should be providing similar services to at least 2 other Govt. /PSUs/private organization of same capacity. Current work order copy issued by them should be enclosed as proof
- (v) The company should have in-house Test and Repair Center at Delhi. This may be inspected by DOT authorities in case of need.
- (vi) The Firm to be selected should have CNE, CCNA, CCNP, MCSE, RHCE and other Certified Engineers to take care of the network and to provide solutions on the spot.
