- 2- Clause a (ii) may be read as '**Jr./Sr. Accountants, Clerks/PAs who have qualified in both part-I & II of JAO (Civil)/SAS/SOGE or equivalent examination conducted by any of the Organized Accounts, Deptt. of Central Govt./State Governments with five years combined regular service in the cadre as on date**' instead of '**Jr./Sr. Accountants, Clerks/PAs who have qualified in both part-I & II of JAO (Civil)/SAS/SOGE or equivalent examination conducted by any of the Organized Accounts, Deptt. of Central Govt., with five years combined regular service in the cadre as on date**'
