
Subject: Amendment of UAS Licence Agreement with respect to Service Testing and Issue of Certificate.

In pursuance of clause 5.1 of the UAS licence agreement, inter-alia, reserving the right to modify at any time the terms and conditions of the LICENCE, in public interest or for the proper conduct of the SERVICE, the LICENSOR hereby substitutes clause 8 of UAS licence agreement with immediate effect with the following clause, namely :-

"8. Delivery of Service

8.1 The LICENSEE shall commission the Applicable Systems within one year from the effective date of the Licence. The date of Test Certificate issued by the Authorised Testing Party of the Licensor as specified from time to time shall be reckoned as the date of commissioning the service for the purpose of calculating liquidated damages in terms of Condition 35 of the Licence Agreement. However, the LICENSEE may start providing service to customers at any time without the need of specific approval of the Licensor."

2. All other term and conditions of the licence agreement including amendments and instructions issued from time to time shall remain unchanged.
