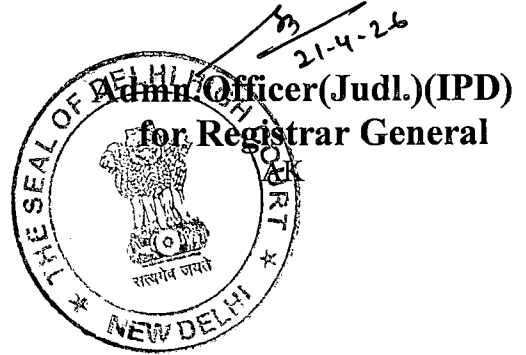

1. The plaintiff is seeking to implead rogue-websites as defendant nos. 165 to 184 because they have been found to be indulging in illegally disseminating the copyrighted material belonging to the plaintiff. The application has been moved in terms of the liberty granted by the Hon'ble Court on **13.12.2024**, contained in **paragraph 37(g) to 37 (j)** of the said order.
2. The application is supported by the required affidavit. Keeping in view the contents of the suit and the application, the



same is allowed. The proposed defendants are impleaded as defendant nos. 165 to 184.

3. The amended memo filed alongwith this IA is taken on record. Steps be taken to serve the newly impleaded defendants with summons within two weeks through electronic mode. Process fee be filed within a week.

4. The order blocking the rogue-websites and injunction order passed by the Hon'ble Court on **13.12.2024** shall operate qua the freshly impleaded defendants as well. Further, the concerned DNR's are directed to lock and suspend / deactivate the rogue websites impleaded today. The concerned ISPs /TSPs are directed to block the rogue websites impleaded today. Plaintiff shall comply with Order 39 Rule 3 CPC and file compliance affidavit within a week. **IA is allowed and disposed off** accordingly.

1. As the present suit contemplates urgent interim relief, in light of the judgment of the Supreme Court in *Yamini Manohar v. T.K.D. Krithi*, 2023 SCC Online SC 1382, exemption from the requirement of pre-institution mediation is granted.

2. The application stands disposed of.

3. The present application has been filed on behalf of the plaintiffs seeking leave to file additional documents under the Commercial Courts Act, 2015.

4. The plaintiffs are permitted to file additional documents in accordance with the provisions of the Commercial Courts Act, 2015 and the Delhi High Court (Original Side) Rules, 2018.

9. This application has been filed on behalf of the plaintiffs seeking exemption from filing documents in separate volumes.

10. For the reasons stated in the application, the same is allowed and the plaintiffs are exempted from filing documents in separate volumes.

11. The application stands disposed of.

12. Let the plaint be registered as a suit.

13. Issue summons.

14. Summons are accepted by counsel appearing on behalf of the defendant no. 86/ Google LLC.

15. Summons be issued to the defendants no. 1 to 86 through e-mail alone and to the defendants no. 87 to 103 through all permissible modes. The summons shall state that the written statement(s) shall be filed by the



defendants within thirty days from the date of the receipt of summons. Along with the written statement(s), the defendants shall also file affidavit of admission/denial of the documents of the plaintiffs, without which the written statement(s) shall not be taken on record.

16. Liberty is given to the plaintiffs to file replications, if any, within thirty days from the receipt of the written statement(s). Along with the replications filed by the plaintiffs, affidavit of admission/denial of the documents of the defendants be filed by the plaintiffs.

17. The parties shall file all original documents in support of their respective claims along with their respective pleadings. In case parties are placing reliance on a document, which is not in their power and possession, its detail and source shall be mentioned in the list of reliance, which shall also be filed with the pleadings.

18. If any of the parties wish to seek inspection of any documents, the same shall be sought and given within the timelines.

19. List before the Joint Registrar on 19th February, 2025 for completion of service and pleadings.

20. List before the Court on 2nd April, 2025.

I.A. 48162/2024 (O-XXXIX Rules 1 and 2 of CPC)

21. The present suit has been filed seeking relief of permanent injunction, restraining the defendants from committing piracy of the plaintiffs' works, from infringing the copyright and broadcast reproduction rights of the plaintiffs and to block access to the defendants no. 1 to 71's rogue websites/URLs as identified by the plaintiffs, along with other ancillary reliefs.



22. It is submitted that the plaintiffs no.1 to 3 are sister concerns/affiliated companies. The plaintiffs are engaged in production, acquisition and distribution of various cinematographic films and audio-visual content in various Indian languages, in multiple formats worldwide including but not limited to, theatrical, television, digital and internet platforms, cloud platforms. The plaintiffs are one of the largest Indian provincial music and film producer, distributor, and aggregator, and have produced/released over 60+ films either alone or in collaboration with other media and production houses including but not limited to 'Zindagi Zindabaad', 'Cheta Singh', 'Snowman', 'Kulche Chole', 'Television', 'Posti', 'Maa', 'Warning', 'Ikko Mikke', 'Happy Go Lucky', 'Manje Bistre', 'The Black Prince', 'Zindagi Kitni Haseen Hay', among others.

23. The plaint asserts that the plaintiffs have the exclusive rights to publicly exhibit and communicate through any medium or mode (hereinafter, "plaintiffs' works"). The plaintiffs' works are protected as "Cinematograph Films" under Section 2(f) read with Section 13 of the Copyright Act, 1957 ("the Act"). The plaintiffs have the exclusive right to make their works available for being seen or heard, or otherwise enjoyed by the public, as enumerated under Section 14(d) of the Act, and further, is also entitled to broadcast reproduction rights in respect of its broadcasts, under Section 37 of the Act.

24. It is stated that the plaintiffs exploit their copyrighted Works/content on Youtube under the label of "Saga Hits", on their own OTT platform "Kableone" and other third party platforms. It is further submitted that a major portion of the plaintiffs' business involves the voluntary licensing of the aforesaid exclusive rights in the plaintiffs' works for exploitation across



all modes and mediums, including various music streaming websites/platforms, internet-based service providers, digital service providers, Over-the-Top (OTT) streaming platforms/service providers, mobile applications, and the like. It is only by exploiting the copyright in such a manner that the plaintiffs are able to sustain their creative activities in the course of their business.

25. It is submitted that the defendants no.1 to 71 (hereinafter referred to as **“defendant Websites” / “Rogue Websites” / “URLs”**) are essentially rogue websites/URLs which are engaged in displaying pirated content by blatantly violating third party rights in order to obtain financial benefits. The nature of these websites is such that they are regularly and consistently updated with new content which is made available to the public without the rights-holders' authorisation and is thereby infringing in nature. The entities who own, operate and manage these rogue websites are unknown as they have opted for privacy protection services of the registrar and are also located at unverifiable locations. The locations of the servers of these rogue websites are unknown and may be located across the world.

26. It is further submitted that these websites are anonymous in nature, i.e., it is virtually impossible to locate the owners of such websites or contact details of such owners, as the information provided in the public domain is either incomplete, incorrect and/or protected/encrypted/hidden.

27. It is stated that the defendants no. 70 and 71 are specific infringing URLs available on cloud storage providers, where the plaintiffs' works are being exploited.

28. It is averred that the defendant websites are 'rogue' in terms of the judgment of this Court in *UTV Software Communications Ltd. v. 1337x.to*



(2019 SCC OnLine Del 8002) as they contain vast volume of third-party content; contain systematic, organized and intentional nature of the infringement; and also due to the regularity and consistency with which content is updated/ uploaded on the said websites.

29. It is averred in the plaint that the defendants no. 1 to 71 Websites/URLs are not authorised to host, upload, stream, reproduce, make available for download, distribute, broadcast, make available to the public or communicate to the public the plaintiffs' works, or facilitate the same, without permission of the rights owners. Thus, the act of hosting, uploading, streaming, reproducing, making available for download, distributing, broadcasting, making available to the public or communicating to the public the plaintiffs' works in India, or facilitating the same, amounts to infringement of the plaintiffs' rights under Section 51 of the Act.

30. It is stated that the defendants no. 72 to 85 are Domain Name Registrars which have been arrayed to block / cancel / suspend the domain name registration of the defendants no. 1 to 69 (and such other websites/URLs which are discovered during the course of the proceeding and notified on Affidavit by the plaintiffs) to have been infringing the copyright in the plaintiffs' works including the future works, and to disclose the certain information about the defendant Websites.

31. It is further stated that plaintiffs have arrayed Google LLC as the defendant no. 86 for the purpose of de-indexing/ delisting of the domain names/ websites of such rogue defendant websites (and such other websites/URLs which are discovered and notified on Affidavit by the plaintiffs) from the search results produced on the search engine, 'Google', and for the purposes of blocking the keywords/terms which are a part of



‘Second Level Domain’ of defendant Websites (and such other websites/URLs which are discovered and notified on Affidavit by the plaintiffs) from the search results available on search engine ‘Google’.

32. It is submitted that the defendants no. 87 to 100 are Internet Service Providers which are being arrayed for the purpose of blocking/ restricting access to the rogue websites identified in the present suit or any other website subsequently identified by the plaintiffs on affidavit.

33. It is stated in the plaint that the plaintiffs have arrayed the defendant no. 101, Department of Telecommunications, and the defendant no. 102, Ministry of Electronics and Information Technology for the issuance of a notification to the internet and telecom service providers to disable access to the defendant Websites identified in the present suit and such other websites subsequently discovered and identified by the plaintiffs to be infringing the rights of the plaintiffs. The defendant no. 103 is ‘John Doe’.

34. Counsel appearing on behalf of the plaintiffs has drawn the attention of this Court to the various infringing content which is available on these rogue websites. The list of the defendant Websites/URLs, and the corresponding pages of the documents filed along with the present plaint, is given in document no. 3 of the documents filed along with the plaint.

35. It is submitted that as the plaintiffs’ works enjoy protection as ‘cinematograph films’ under the Act, the making available and/ or communication to the public of the plaintiffs’ works, without their authorization, by the defendant websites would amount to a violation of the plaintiffs’ exclusive rights under the Act.

36. The balance of convenience is clearly against the defendant Websites, which do not have authorization with respect to the plaintiffs’ works,



including, *inter alia*, to host, stream, reproduce, permit download or distribute, make available to the public and/or communicate the plaintiffs' cinematographic films/original content/work, or facilitate the same. It is submitted that if the illegal activities of the defendant websites are not restrained during the pendency of the present proceedings, plaintiffs shall suffer irreparable harm since it is submitted that the defendant Websites intend to continue to exploit the plaintiffs' property with impunity, thereby, diminishing and diluting the value of the plaintiffs' rights.

37. Accordingly, till the next date of hearing, the following directions are issued:

- a. The defendants no. 1 to 71 (*Annexure-A* of the present order), their owners, partners, proprietors, officers, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under them, are restrained from communicating, hosting, streaming, and / or making available for viewing and downloading in any manner, without authorization, on their websites or other platforms, through the internet in any manner whatsoever, the plaintiffs' works and content related thereto.
- b. The defendants no. 72 to 85 (DNRs) and their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and, on their behalf, or anyone claiming through, by or through them, are directed to lock and suspend the domain name registration of the defendants no. 1 to 69, as per the details given in *Annexure- B* of the present order.
- c. The defendants no. 72 to 85 (DNRs) are directed to disclose the following information:



- i. Complete details (such as Name, Address, Email address, Phone Number, IP Address etc.) of the defendants no. 1 to 69;
 - ii. Mode of payment along with payment details used for registration of domain name by the Registrant i.e., defendants no. 1 to 69.
- d. The defendant no. 86, Google LLC, is directed to de-index / delist the defendants no. 1 to 69 websites, given as *Annexure-A* of the present order.
- e. The defendants no. 87 to 100, their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under it, are directed to block access to the various websites/URLs (defendants no. 1 to 71) identified by the plaintiffs, details of which are given as *Annexure-B* and *Annexure - C*.
- f. The defendants no. 101 and 102 are directed to issue a notification calling upon the various internet and telecom service providers registered under them to block access to the defendants no. 1 to 69 (rogue websites) and the defendants no. 70- 71 (URLs), details of which are given as *Annexure- B* and *Annexure - C*.
- g. If during the pendency of the present suit, any further websites are discovered by the plaintiffs, which are illegally streaming the infringing content, copyright of which is owned by the plaintiffs, the plaintiffs are granted liberty to communicate the details of such websites to the defendant no. 101 (Department of Telecommunications) and the defendant no. 102 (Ministry of



Electronics and Information Technology), for issuance of blocking orders and simultaneously to the Internet Service Providers (“ISPs”) for blocking the said websites.

- h. The DOT and MEITY shall also issue necessary blocking orders immediately upon the plaintiffs, communicating the details of the websites, which are illegally streaming the content, over which the plaintiffs have rights.
- i. Upon receiving intimation from DOT/MEITY, the ISPs shall take steps to immediately block the rogue websites in question.
- j. After communication of details of the rogue websites to the concerned authorities, the plaintiffs shall continue to file affidavits with the Court, in order to ensure that the Court is fully informed of the websites in respect of which blocking orders are sought.
- k. If any website, which is not primarily an infringing site, is blocked pursuant to the present order, they shall be permitted to approach this Court by giving an undertaking that it does not intend to engage in any unauthorized streaming of any content, over which the plaintiffs have rights.
- l. As and when new further websites are discovered by the plaintiffs, the plaintiffs shall be at liberty to file an application for their impleadment, which shall be taken up before the Joint Registrar, and the order passed today shall be extended to the said newly impleaded website(s) as well.

38. In view of the fact that there are several defendants involved, compliance of Order XXXIX Rule 3 of the Code of Civil Procedure, 1908



(CPC) shall be filed within seven (7) days from today.

39. Issue Notice.

40. Notice is accepted by counsel appearing on behalf of the defendant no. 86/ Google LLC.

41. Notice be issued to the defendants no. 1 to 85 through e-mail alone and to the defendants no. 87 to 103 *via* all permissible modes.

42. Reply(ies) be filed within four (4) weeks.

43. Rejoinder(s) thereto, if any, be filed within two (2) weeks thereafter.

44. List before the Joint Registrar on 19th February, 2025 for completion of service and pleadings.

45. List before the Court on 2nd April, 2025.

Subject: Action requested to be taken by MEITY and Plaintiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia states thus:-

'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider).'

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plaintiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plaintiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
