Our Clients also impleaded various internet and telecom service providers, as well as the concerned Government Departments (Department of Telecommunication and the Ministry of Electronics and Information Technology), as Defendants, to ensure effective compliance of any order that the Hon’ble Delhi High Court was inclined to pass.

3. I.A. 23860/2025 (for exemption from filing court fee)

1. This is an application filed by the Plaintiffs under section 149 read with section 151 of the Code of Civil Procedure, 1908, ['CPC'] seeking exemption from filing court fees.
2. Learned counsel for the Plaintiffs states that there are nine (9) Plaintiffs in the suit and each Plaintiff has paid separate court fee for its cause of action against the Defendants.
3. He states that six (6) Plaintiffs have already deposited the court fee certificate.
4. He states that the remaining three (3) Plaintiffs will also deposit their court fee certificate within one (1) week. The time sought for is granted.



5. Accordingly, the application is disposed of.

I.A. 23859/2025 (seeking leave to file additional documents)

6. This is an application seeking leave to file additional documents under Order XI Rule 1(4) of the CPC [as amended by the Commercial Courts Act, 2015].

I.A. 23855/2025 (Under Order XXXIX Rule 1 and 2 CPC)

28. The present suit has been filed seeking relief of permanent injunction, restraining the Defendant Nos. 1 to 106 (rogue websites) from infringing the exclusive rights in the Plaintiffs' original content/work by making their original content/work available for downloading, streaming, uploading and reproducing, along with other ancillary reliefs.

29. Plaintiff Nos. 1-6 are members of Motion Picture Association, Inc. and/or the Alliance for Creativity and Entertainment and Plaintiff Nos. 7, 8 and 9 are members of Copyright Overseas Promotion Association ('COA').

30. Plaintiffs herein are amongst the leading global entertainment companies engaged in the business of creation, production and distribution of motion pictures/cinematograph films.

31. It is averred in the plaint that the cinematograph films/shows produced by Plaintiffs are 'work' as defined under Section 2(y) of the Copyright Act, 1957 ['the Act']. Plaintiffs have all the rights granted under Section 14(d) of the Act in such cinematograph films/shows. Plaintiffs are the author and/ or first owner and/ or owners and/or exclusive distributors in India. The illustrative list of cinematograph films that are entitled to



protection under the Act is set out at paragraph 23 of the [plaint](#).

32. It is stated that since these works are released or published in India, they are entitled to protection under Sections 13(1), 13(2), and 13(5) of the Act. Even in cases where the works are not first published in India, they are still protected under Section 40 of the Act, which extends copyright protection to foreign works.

33. It is stated that the Plaintiffs have exclusive rights to communicate their content to the public.

34. The Plaintiffs have filed this suit against 106 rogue websites (Defendant Nos. 1-106) with additional domains, which substantially indulge in online piracy by making available for download and otherwise providing access to infringing and illegal content. The list of Defendant Nos. 1-106 is set out at [paragraph 33 of the \[plaint\]\(#\)](#).

35. It is the case of the Plaintiffs that the Defendant Nos. 1 to 106 Websites primarily and substantially engage in, *inter alia*, communicating to the public, hosting, uploading, streaming, reproducing, downloading, broadcasting, distributing and/or making available to the public Plaintiffs' Original Content without authorization, and/or facilitating the same. Defendant Nos. 1- 106 are making available, illegally and unauthorizedly, the Plaintiffs' Original Content.

36. An illustrative list of the Plaintiffs' copyright-protected cinematograph films that are unauthorizedly made available by the Defendants Nos. 1 to 106 is set out at [paragraph 37 of the \[plaint\]\(#\)](#).

37. Plaintiffs issued take-down notices to the Defendant Websites on 10.09.2025 to which only Defendant No. 42 replied, claiming that he merely indexes and organizes content which is publicly made available and does not host or store any content. However, after receiving the said response,



Plaintiffs investigator has collected evidence to show that the Plaintiffs' Original Content continues to be made available on Defendant No. 42's website as late as 14.09.2025

38. It is further contended that despite sending the legal notices and calling upon the concerned Defendants to cease engaging in their infringing activities, the Defendants continue to infringe the rights of the Plaintiffs' original content. It is also contended that access to Defendant Nos. 8, 9, 12, 16, 24, 38, 50, and 65 has also been disabled in Australia details of which are given at paragraph 45 of the plaint. It is also stated that Defendant domains with identical names but with different top-level domains have been blocked in different jurisdictions, e.g., Defendant No. 2 'hindilinks4u.doctor' with identical names but with different top-level domains 'hindilinks4u.nl' has been blocked in Australia.

39. Learned Counsel for the Plaintiffs' states that the Defendant Nos. 1 to 106 are liable for infringement under Section 51(a)(ii), Section 51(b), and Section 51(a)(i) of the Act, for making a copy of the Original Content including the storing of it in any medium by electronic or other means and communicating the Original Content to the public. Further the hosting, streaming, reproducing, distributing, making available to the public, and/or communicating to the public of the Original Content, or facilitating the same, without authorization of the Plaintiffs amounts to violation of the Plaintiff's copyright work, protected under the Copyright Act, 1957. In support of his contentions reliance has also been placed on the decision of this court in CS(COMM) 724/2017 dated 11.04.2019, **UTV Software**



Communication Ltd. vs. 1337X.TO and Ors¹.

40. Defendant Nos. 107-129 are the Domain Name Registrants ('DNRs') which are being arrayed for the limited purpose of locking and suspending the rogue websites.

41. Defendant Nos. 130-138 are the Internet Service Providers ('ISPs') which are being arrayed for the limited purpose of restricting or blocking access to the rogue websites in India.

42. Defendant Nos. 139 and 140 are the Department of Telecommunications ('DOT') and Ministry of Electronics and Information Technology ('MEITY') respectively, which are Government departments and are being arrayed for the limited purpose to issue notification calling upon ISPs to block access to the rogue websites identified in the present suit as also such other websites which are subsequently discovered to be infringing the rights of the Plaintiffs.

43. Defendant No. 141, i.e., Toho Co. Ltd. is the copyright owner of the work, for which Plaintiff No. 6 is the exclusive distributor, in India. Defendant No. 141 has been arrayed in the suit in compliance with Section 61 of the Act.

44. The Court has heard the learned counsel for the Plaintiffs and has perused the record.

45. Based on the averments made in the plaint, the Plaintiffs have established themselves as the owner of their works in the original content motion pictures/cinematographic films.

46. Additionally, in view of the judgment passed in **UTV Software Communication Ltd.** (supra), this Court is of the opinion that a prima facie

case is made out in favour of the Plaintiffs and balance of convenience is also in its favour. Further, irreparable harm or injury would be caused to the Plaintiffs if an ad-interim injunction order is not passed. The need for immediate relief is particularly pressing in this case as the Defendant Nos. 1 to 106 are making available the Original Content of the Plaintiffs, which could lead to significant financial losses for the Plaintiffs.

47. Accordingly, till the next date of hearing, following directions are issued:

- I. Defendant Nos. 1 to 106, names of which are mentioned in SCHEDULE-A annexed with this Order, (and any such other mirror/redirect/alphanumeric website which appears to be associated with any of the Defendant Websites either based on its name, branding or the identity of its operator, or source of the content or discovered to provide additional means of accessing, Defendant Websites, and other domains/domain along with their subdomains and subdirectories, owners/website operators/entities which are discovered to have been engaging in infringing the Plaintiffs' exclusive rights), its owners, partners, proprietors, officers, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under it, are restrained from, in any manner hosting, streaming, reproducing, distributing, making available to the public and/or communicating to the public, or facilitating the same, on their websites, through the internet in any manner whatsoever, any cinematograph work/content/programme/show in relation to which Plaintiffs have copyright or exclusive distribution rights/ and or any other right;



- II. Defendant Nos. 107 to 129 (DNRs) as mentioned in **SCHEDULE-B** annexed with this Order, and other DNRs, their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under it, are directed to lock and suspend and provide details relating to the registrant of the said Defendant Nos. 1 to 106 Websites, including KYC, credit card, mobile number etc., to the Plaintiffs identified by the Plaintiffs in the instant suit (and any such other mirror/redirect/alphanumeric website which appears to be associated with any of the Defendant Websites either based on its name, branding, the identity of its operator, or the source of the content or discovered to provide additional means of accessing the Defendant Website, and other domains/domain along with their subdomains and subdirectories, owners/website operators/entities which are discovered to have been engaging in infringing the Plaintiffs' exclusive rights) within 72 hours of being communicated with a copy of this order;
- III. Defendant Nos. 130 to 138 (ISPs), their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under it, are directed to block access to the Defendant Nos. 1 to 106 websites identified by the Plaintiffs and annexed as **SCHEDULE-A** with this Order (and any such other mirror/redirect/alphanumeric website which appears to be associated with any of the Defendant Websites either based on its name, branding or the identity of its operator, or the source of the content or



discovered to provide additional means of accessing, the Defendant Website, and other domains/domain along with their subdomains and subdirectories, owners/website operators/entities which are discovered to have been engaging in infringing the Plaintiffs' exclusive rights) within 72 hours of being communicated with a copy of this order;

IV. Defendant Nos. 139/DOT and 140/MEITY, are directed to issue a notification calling upon the various internet and telecom service providers registered under it to block access to the Defendant Nos. 1 to 106 websites identified by the Plaintiffs and annexed as SCHEDULE-A with this Order (and any such other mirror/redirect/alphanumeric website which appears to be associated with any of the Defendant Websites either based on its name, branding or the identity of its operator, or the source of the content or discovered to provide additional means of accessing, the Defendant Websites, and other domains/domain along with their subdomains and subdirectories, owners/website operators/entities which are discovered to have been engaging in infringing the Plaintiffs' exclusive rights) within 72 hours of being communicated with a copy of this order.

48. To keep up with the hydra-headed nature of the infringement actions of such infringing domains/websites, this Court finds it fit to grant a 'Dynamic+ injunction' to protect copyrighted works as soon as they are created, to ensure that no irreparable loss is caused to the owners of copyrighted works, as there is an imminent possibility of works being uploaded on infringing websites or their newer versions immediately thereafter. Plaintiffs are permitted to implead any mirror/ redirect/ alphanumeric variations of the websites identified in the suit as Defendants



Nos. 1 to 106, including those websites which are associated with them, either based on the name, branding, identity or even source of content, by filing an application for impleadment under Order I Rule 10 of the CPC and extend the present order against them, in the event such websites merely provide new means of accessing the same primary infringing websites that have been enjoined.

49. If any website, which is not primarily an infringing website, is blocked pursuant to the present order, they shall be permitted to approach the Court by filing an Affidavit that it does not intend to engage in any unauthorized or illegal dissemination of cinematograph films/ shows or any other content over which the Plaintiffs have rights. In such a situation, the Court would consider modifying the injunction as the facts and circumstances so warrant.

50. Issue notice.

51. Mr. Yash Raj, learned counsel on behalf of the Defendant Nos. 113 and 115 accept summons. He confirms the receipt of the suit paper-book and waives the right of formal service of summons.

52. Issue notice to remaining Defendants by all permissible modes.

53. Reply to the application be filed within four (4) weeks. Rejoinder thereto, if any, be filed within three (3) weeks thereafter.

54. Since, Defendant Nos. 107 to 140 are arrayed for compliance of the Orders passed by the Court, they are exempted from filing reply to this application.

55. Compliance affidavit be filed by Defendant Nos. 107 to 140 within two (2) weeks.

56. Learned counsel for the Plaintiffs has handed over a convenience



volume along with a written note titled as “Evidence Key” to illustrate the infringing activities of the Defendant Nos. 1 to 106.

The Plaintiffs are directed to e-file the said convenience volume and Evidence Key with the Registry. s

57. List before the learned Joint Registrar (J) for completion of service and pleadings on **10.11.2025**.

58. List before the Court on **20.03.2026**.

59. The digitally signed copy of this order, duly uploaded on the official website of the Delhi High Court, www.delhihighcourt.nic.in, shall be treated as a certified copy of the order for the purpose of ensuring compliance. No physical copy of order shall be insisted by any authority/entity or litigant.

Annexure

Subject: Action requested to be taken by MEITY and Plaintiff for effective removal of content for viewing by public at large within India as per the said orders of Hon'ble Court.

It is observed that a number of orders of Hon'ble Court are issued for blocking of websites every month. There are around more than 2700 ISPs in India and these ISPs are connected among themselves in a mesh network. DOT is instructing each of the ISPs through emails/through its website for blocking of the websites as ordered by the Hon'ble Courts. Ensuring compliance of the orders by each of the ISPs is a time-consuming and complex task especially in view of multiplicity of orders of Hon'ble Courts, multiplicity of websites to be blocked and multiplicity of ISPs.

2. Allocation of Business Rules inter-alia states thus:-

'Policy matters relating to information technology; Electronics; and Internet (all matters other than licensing of Internet Service Provider).'

3. In view of above and in order to ensure effective removal by content for viewing by public at large, the plaintiff is requested to do a trace route of the web server hosting the said website. In case the web server happens to be in India, the plaintiff may inform the same to Meity who may direct the owner of such web server to stop transmission of content as per IT Act and as directed by the Hon'ble Court so that the content would be blocked from the source itself and the exercise of blocking by 2700 ISPs would not be required.

4. In case such server is located abroad i.e. outside India then access to such URL/website can be blocked through the international internet gateways which are much less in number. This would result in timely and effectively removal of undesirable content for viewing by public at large as is the requirement as per the orders of Hon'ble Court.
